ORDINANCE NO. 18-822

AN ORDINANCE AMENDING CITY OF HUMBLE ORDINANCE 17-809, PASSED AND APPROVED THE 14TH DAY OF SEPTEMBER 2017 AND BEING AN ORDINANCE ADOPTING THE CITY OF HUMBLE BUDGET FOR FISCAL YEAR 2017-2018, BY ADDING TO THE BUDGET ADOPTED HEREBY AN ADDENDUM NO. 1; PROVIDING FOR A CERTAIN AMENDMENT TO SUCH BUDGET; MAKING CERTAIN FINDINGS; AND PROVIDING OTHER MATTERS RELATED TO THE SUBJECT.

WHEREAS, following proper notice and public hearing, the City Council adopted the City of Humble Budget for Fiscal Year 2017-2018 on September 14, 2017; and

WHEREAS, a reallocation of monies between line items and an increase in monies of certain line items for capital expenditures to said budget is necessary; and

WHEREAS, the City Council of the City of Humble, Texas hereby find and determines that public necessities require the adoption of such amendment; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, THAT:


Section 1. The facts and matters set forth in the preamble of this Ordinance are found to be true and correct.



Section 4. That this ordinance shall be effective immediately, upon passage.

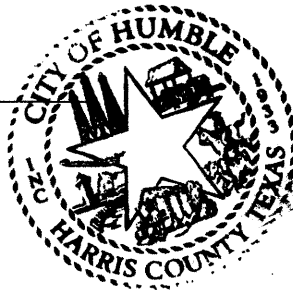
