Applicant certifies that the occupation tax has been paid for each amusement redemption machine within the premises and is responsible for paying the game room license and inspection fee of \$300.00 payable to the City of Humble, Texas.

Amusement Redemption Machine License is valid from January  $\mathbf{1}^{st}$  through December  $3\mathbf{1}^{st}$  and must be renewed annually. Applicant may file the renewal application and associated fees for the following calendar year beginning on October  $\mathbf{1}^{st}$ .

Please note, this application is for the licensing of a premise to operate Amusement Redemption Machines. The applicant/business/owner/operator is still responsible for the filing of the Application for Coin Operated Game Machine Permit for each machine located within their premises.
