5. PUBLIC HEARING REGARDING APPLICATION FOR BUREAU OF JUSTICE ASSISTANCE 2007 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM IN THE AMOUNT OF \$ 12,754.00 TO FUND OVERTIME FOR POLICE OFFICERS TO PROVIDE EXTRA PATROL DUTIES IN HIGH CRIME AREAS INCLUDING APARTMENT COMPLEXES AND SUBDIVISIONS

Mayor McMannes called the public hearing to order for comments regarding submittal of an application to the Bureau of Justice for a 2007 Edward Byrne

Memorial Justice Assistance Grant in the amount of \$ 12, 754.00. The grant would fund overtime for police officers to provide extra patrol duties in high crime areas including apartment complexes and subdivisions. Chief Warman and Assistant Chief Mills stated the funds were offered to area departments for crime control. Mayor McMannes closed the public hearing with no comments from the public.

8. RESOLUTION NO. 07-668 ADJUSTING THE CITY OF HUMBLE WATER RATES AND WATER AND SEWER TAP FEES

City Manager Boeske presented Resolution No. 07-668 to the mayor and councilmembers for approval. He stated the water rate adjustment was needed as the city will be subject to rate increases from the City of Houston for the portion of the water they supply to the city of Humble and the taps fees had not been adjusted in many years and the city was losing money on each tap. He then recommended approval of the resolution. Mayor McMannes moved to adopt Resolution No. 07-668. Councilman Curry inquired about the senior citizen rates and was informed the senior citizen base rates would remain the same but the price of each thousand gallons after the base five thousand would be \$1.25. The mayor called for the vote.

11. SUBDIVISION REPLAT - ADVANCED AUTO - WILSON ROAD AND FIRST STREET

City Manager Boeske asked that consideration on the replat for Advanced Auto be deferred until the next council meeting as the city engineer has not completed his review of the project.

12. AUTHORIZATION TO ENTER INTO SERVICE AGREEMENT WITH KLOTZ ASSOCIATES FOR CITY OF HUMBLE MASTER DRAINAGE PLAN

City Manager Boeske presented a proposed service agreement with Klotz Associates for a Master Drain Plan for the city in the amount of \$ 35,000.00. The scope of the project would include:

- 1. Confirm with the City of Humble key drainage issues and areas of specific problems or concerns which should be addressed for the benefit of the City.
- 2. Gather detailed information related to the Harris County Flood Control District's (HCFCD) Watershed Master Plan (WMP) for the Humble area watersheds. Review this recent update of the watersheds and confirm target improvements. Participate in meetings with HCFCD on the WMP for Greens Bayou.
- Gather detailed information related to the Houston Airport Systems Water Shed Master Drainage Plan. Review this plan in terms of targeted improvements identified for the region.

- 4. Develop a plan to engage the HCFCD on regional drainage improvements which offer key solutions for the City of Humble's long term drainage needs.
- 5. Prepare a summary report which targets these regional solutions and potential partners for the City of Humble. Additionally, identify what portion of the attached master drainage plan tasks which may be significantly reduced due to efforts already done by HCFCD or the Houston Airport System.

Councilman Steagall moved to enter into a service agreement with Klotz Associates for a drainage study for the city.

13. WORKSHOP MEETING - PROPOSED CITY OF HUMBLE BUDGET FOR FISCAL YEAR 2007-2008

City Manager Boeske presented the proposed City of Humble Budget for fiscal year 2007-2008. He read his letter to the mayor and council as presented in the proposed budget.

In compliance with Chapter 2, Article II, Sec.2 -31(7), City of Humble Code of Ordinances. I present for your review Estimates of Revenue and Expenditures for the fiscal year beginning October 1, 2007 and ending September 30, 2008. Estimated Ad Valorem Tax revenue is based on an assessed valuation of \$1,000,000,000.00 and computed on a tax rate of \$0.20 per \$100.00 assessed valuation. 100% of the rate is assessed for maintenance and operation of the City. The proposed M & O rate is subject to a public hearing in accordance with provisions of the Texas Property Tax Code.

Estimated expenditures provide for maintenance and operation of the city, employee salaries, benefits, and capital expenditures in various city departments.

I trust the information presented will be helpful in preparing the fiscal year budget and I recommend that a workshop session be held during the month of August, 2007 for that purpose. I

also recommend that a public hearing in accordance with the Texas Property Tax Code be held at 6:00 p.m. on Thursday, September 13, 2007.

The city manager then presented the Combined Statement of Estimated Revenue and Expenditures.
