**NOTICE IS HEREBY GIVEN** in accordance with an Order of the Office of the Governor issued March 16, 2020; the City Council of the City of Humble will conduct its Special Meeting scheduled for 11:00 a.m. on December 19, 2020, in person and open to the public. In order to advance the public health goal of limiting face-to-face meetings (also called “social distancing”) to slow the spread of the Coronavirus (COVID-19), seating will be limited to 50% Fire Code capacity or 25 people per meeting room or to reasonably allow 6 feet separation. Overflow into the hallway is allowed, but there will not be video or audio enhancement in this area. The meeting will not be available via telephone or videoconferencing. Citizens who wish to attend the City Council Meeting in person must abide by the following requirements:


- Do not enter the building if you are having symptoms. Go home.
  - Maintain a minimum distance of 6 feet from other citizens.
  - Families or persons traveling together may sit together, but maintain social distancing from others.
  - Face coverings are encouraged, but not mandatory.
