NOTICE IS HEREBY GIVEN THAT THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS WILL HOLD A PUBLIC HEARING ON THURSDAY, SEPTEMBER 10, 2009 FROM 6:00 P.M. UNTIL 6:30 P.M. IN THE CITY COUNCIL CHAMBERS LOCATED IN CITY HALL, 114 WEST HIGGINS, HUMBLE, TEXAS.

THE PURPOSE OF THE PUBLIC HEARING IS FOR CONSIDERING THE ADOPTION OF THE PROPOSED BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2009 AND ENDING SEPTEMBER 30, 2010. AT THIS TIME ALL CITIZENS OF THE CITY OF HUMBLE WILL BE GIVEN AN OPPORTUNITY TO PROVIDE WRITTEN OR ORAL COMMENTS AND TO ASK QUESTIONS CONCERNING THE PROPOSED BUDGET.

THIS BUDGET IS ESTIMATED TO RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEARS'S BUDGET BY \$ (16,000.00) - A DECREASE OF 6%. BASED ON TAXABLE VALUE INFORMATION CURRENTLY AVAILABLE FROM THE HARRIS COUNTY APPRAISAL DISTRICT, IT IS NOT POSSIBLE AT THIS TIME TO DETERMINE THE AMOUNT OF THIS ADDITIONAL PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE ROLL THIS YEAR.

Currently an employee may accrue 30 sick days but with the new plan, forty eight days could be accrued and then they could bank sick leave days to allow them to receive pay for a maximum of thirty days when they retire or leave their employment. #### ORDINANCE NO. 09-673

AN ORDINANCE ADOPTING THE 2009-2010 BUDGET FOR THE CITY OF HUMBLE, TEXAS; APPROPRIATING THE SEVERAL SUMS ALLOCATED FOR THE PURPOSE THEREIN NAMED; PROVIDING AN EFFECTIVE DATE

- WHEREAS, the budget for the City of Humble for the fiscal year beginning October 1, 2009 and ending September 30, 2010 was presented for consideration; and
- WHEREAS, notice of a public hearing on said budget was duly given as required by law, that such hearing was duly held prior to the time the City Council levied taxes for the fiscal year; Now, therefore:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS:

- SECTION 1. That the budget for the fiscal year beginning on October 1, 2009 and ending September 30, 2010, be, and the same is hereby in all respects approved and adopted.
- SECTION 2. That the several amounts allocated for the purposes named in said budget be, and they are hereby appropriated for such purposes.
- SECTION 3. That this Ordinance shall take effect immediately and be in full force upon and after its adoption.
