RESOLUTION NO. 10-698

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS AUTHORIZING THE SUBMISSION OF THE TEXAS TRAFFIC SAFETY PROGRAM GRANT APPLICATION AND AGREEMENT

WHEREAS, the City of Humble recognizes that the establishment, development, and maintenance of a program of traffic safety in the State of Texas is a vital government purpose and function of the State of Texas and its legal and political subdivisions; and

WHEREAS, a traffic safety grant will provide benefits to the community in the form of a reduction in the number of crashes and the resulting loss of lives and property damage; and

WHEREAS, funds have been established and are available from the Texas Department of Transportation for grants to local governments for traffic safety projects;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Humble authorizes the submission of an application to the Texas Department of Transportation for a Traffic Safety Grant and, if the project is selected for funding, Mayor D. G. McMannes of the City of Humble is hereby authorized and empowered to execute in the name of the Humble City Council all necessary applications, contracts, and agreements to implement and carry out the purposes specified in this resolution.
