Mayor Donnie McMannes called the special meeting of the Humble City Council to order at 9:00 a.m. with all members present except Councilmember Bill Conner.

### 1. INVOCATION/PLEDGE OF ALLEGIANCE

Assistant City Manager Mark Martin gave the invocation and led the Pledge of Allegiance.

2. ORDINANCE NO. 12-699 SETTING THE AD VALOREM TAX RATE OF THE CITY OF HUMBLE FOR THE YEAR 2011 AT A RATE OF \$0.20 PER ONE HUNDRED DOLLARS (\$100.00) VALUATION ON ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF HUMBLE AS OF JANUARY 1, 2011; SETTING TAX RATE FOR MAINTENANCE AND OPERATIONS; LEVYING AN AD VALOREM TAX FOR THE YEAR 2011; AND OTHER RELATED MATTERS

City Manager Darrell Boeske presented Ordinance No. 12-699 to the mayor and councilmembers and recommended approval.

### ORDINANCE NO. 12-699

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, SETTING THE AD VALOREM TAX RATE OF THE CITY OF HUMBLE FOR THE YEAR 2011 AT A RATE OF \$0.20 PER ONE HUNDRED DOLLARS (\$100.00) VALUATION ON ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF HUMBLE AS OF JANUARY 1, 2011; SETTING TAX RATE FOR MAINTENANCE AND OPERATIONS; LEVYING AN AD VALOREM TAX FOR THE YEAR 2011; AND OTHER RELATED MATTERS

WHEREAS, the appraisal roll of the City of Humble, Texas for 2011 has been prepared and certified by the Harris County Appraisal District and submitted to the City of Humble's Tax Assessor/Collector – Don Sumners; and

WHEREAS, the City's Tax Assessor/Collector has submitted the appraisal roll for the City showing \$1,176,107,664.00 to be the total appraised, assessed and taxable value of all property and the total taxable value of new property to the City; and

WHEREAS, following notice in accordance with applicable legal requirements and based upon said appraisal roll, the City Council has determined a tax rate to be levied for 2011 sufficient to provide the tax revenue required by the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS:

Section 1. That an ad valorem tax rate of \$ 0.20 per one hundred dollars assessed valuation is hereby adopted for the 2011 calendar year, such rate consisting of the following specified component: for maintenance and operations, \$0.20 per one hundred dollars assessed valuation.

Section 2. That an ad valorem tax for the 2011 calendar year in the amount established by the rate herein above provided is hereby levied and assessed on all taxable property, real, personal and mixed, situated within the corporate limits of the City of Humble, Texas, and not otherwise exempt under the Constitution and laws of the State of Texas.

Section 3. That the City of Humble Tax Assessor/Collector is hereby authorized to assess and collect the taxes of the City of Humble, Texas, employing the above tax rate.

Section 4. That all ordinances and parts of ordinances in conflict with this ordinance be and the same are hereby repealed to the extent of said conflict.

Section 5. That this ordinance shall take effect immediately of and from the date of adoption.

Councilmember Merle Aaron moved to approve Ordinance No. 12-699 setting the ad valorem tax rate for the City of Humble.
